

The online service contains all Kopiosto's mandates: the AV Copyright Agreement, the AV Proxy and the Kopiosto Proxy. Through the service the rightsholders may manage their data, check the status of their own mandates, and change their own mandates. With different search criteria the member organizations can browse the mandates given to them. Kopiosto admins the service.

©-Info

Kopiosto has developed a ©-info icon. ©-info can be added on websites or in PDF documents. By clicking on the icon, you can find out who made and produced the content: images, articles, videos, and other material on webpage. The information also includes how the content on the webpage, or the material can be used or copied. For authors and publishers ©-info is a tool to make copyrights visible, and for the users ©-info is a standard icon to tell how I can use the content.

The use of the icon is free of charge. It can be added to any website or PDF document. The icon helps the users to find the authors and usage rights of the content quickly and easily.

Joint ISNI project was launched in February 2022

Five CMOs and the National Library of Finland launched a new project in February. The aim of the project is to enrich creative industry metadata and acquire ISNIs (International Standard Name Identifier) comprehensively for rightholders represented by copyright organizations. The target of the project is the better identification of authors and their works.

The National Library of Finland coordinates the project as the national ISNI Registration Agency. The Finnish Copyright Management Organizations Gramex, Kopiosto, Kuvasto, Sanasto and Teosto are involved in the project. The project will run until the end of 2023.

Communication

In recent years, Kopiosto's communications has made significant efforts in developing its social media channels (Facebook, Instagram, Twitter and LinkedIn). We have emphasized the role of planning ahead and connecting content production to overall communication strategies and processes. This includes monitoring our social media analytics, such as engagement or audience growth metrics, and utilizing these insights in developing our content production even further. For example, merely making sure that our visual content aligns with the technical requirements of a given channel may have a significant impact in how well content succeeds.

	<p>Mainly this development work has been to actualize communication basics in our social media channels – to shape our messages fitting to the target audience and channel in question. This includes finding the right channels for specific audiences. For example, last year we organized a paid social media campaign to reach new audiences among creative workers and the results suggest that there is still much potential yet unleashed in increasing visibility of our messages in social media in Finland.</p>
